10. DESCRIPTION OF CONTRACT MODIFICATION:

This modification makes the following changes to the Contract for all pertinent purposes:

Capital Metro is directing this modification pursuant to Exhibit E - Revised-2, Contractual Terms and Conditions, Section 15 entitled **CHANGES**, to be made a part hereof for all pertinent purposes, the changes are as follows:

- 1) Refer to Exhibit A, Revised-6, Pricing Schedule. Exhibit A, Revised-6, shall be replaced in its entirety with <u>Exhibit A, Revised-7</u>, attached hereto and made a part hereof for all pertinent purposes. Changes are highlighted in yellow and marked with a vertical line in the margin.
- 2) Fully burdened labor rates for 3 new LTK personnel are added to Exhibit A, Revised-7, Pricing Schedule, Sections 11-13.
- 3) Reference Exhibit E Revised-2, Contractual Terms and Conditions Section 12, Subcontractors and Outside Consultants. - 6) All other Terms and Conditions remain the same and in full force and effect and apply to this sub-contractor.

Bowman Engineering and Consulting Inc. shall adhere to Contract 200107, Exhibit F - Scope of Services, section 1. (c) which states, "There will be no requirement for engineering or architectural services associated with this contract."

For and in consideration of the amount stated above, which is the final contract modification amount agreed to by both parties, the receipt of and sufficiency of which is hereby acknowledged and confessed. The contractor has released, acquitted, and forever discharged and by the presents does for itself, its successors and assigns release, acquit and forever discharge Capital Metropolitan Transportation Authority (Capital Metro) from and against any claims, debts, demands, or cause of action which the contractor has or may have had a result of furnishing labor, supplies, or materials for the change orders stated above.
