10. DESCRIPTION OF CONTRACT MODIFICATION:

This modification is made in accordance with Exhibit E-Revised-1 Contractual Terms and Conditions, Section 5, ADDITIONAL OPTION TO EXTEND CONTRACT PERFORMANCE.

This contract modification extends the service period until March 30, 2026, at the pricing specified in Exhibit A - PRICING SCHEDULE, Section 7, Item 7. This section pertains to the Consolidated Maintenance Program for Rail, Rapid, Fixed Route, and APC Systems, specifically OPTION YEAR 4 (Year 5 of the Contract), covering the period from October 1, 2025, to March 30, 2026. Services will be provided at contract rates with a 3% increase for the six-month period, as detailed in Exhibit F, Scope of Services, with the total amount not to exceed \$141,962.00.

This modification may be executed in multiple originals, and an executed facsimile shall have the same force and effect as an original document.

For and in consideration of the amount stated above, which is the final contract modification amount agreed to by both parties, the receipt of and sufficiency of which is hereby acknowledged and confessed.
