10. DESCRIPTION OF CONTRACT MODIFICATION:

1. This Contract Modification exercises the twelve (12) month option in accordance with Exhibit E—Revised-2, Contractual Terms and Conditions, Paragraph 4, OPTION TO EXTEND CONTRACT TERM at the prices detailed in Exhibit A, Pricing Schedule, Section 11, Items 1 through 4, Option Period 5 (Contract Year 6), for the total amount of \$80,380.72. The term shall be from October 22, 2025 through October 22, 2026.
2. In view of the above, the total amount of the Contract is increased by \$80,380.72 from \$362,823.44 to **\$443,204.16**.
3. All other terms and conditions are to remain unchanged.

For and in consideration of the amount stated above, which is the final contract modification amount agreed to by both parties, the receipt of and sufficiency of which is hereby acknowledged and confessed.
