10. DESCRIPTION OF CONTRACT MODIFICATION:

This Contract is modified in accordance with Exhibit E, Contractual Terms and Conditions, Section 4., Option to Extend Contract Term, to be made a part hereof for all pertinent purposes. Modification 2 exercises option period 2, year 5 of the contract. Pricing for option period 2 is based on fully burdened labor rates for task orders as indicated in Exhibit A (Pricing Schedule), Section 10. The new Contract expiration date is November 30, 2026.
