10. DESCRIPTION OF CONTRACT MODIFICATION:

1. This Contract Modification is made in accordance with Exhibit E – Revised-1, Contractual Terms and Conditions, Paragraph 4, OPTION TO EXTEND CONTRACT TERM, to be made a part hereof for all pertinent purposes.
2. This modification 5 exercises a twelve (12) month unilateral option for Option Year 4, (Year 5 of the Contract), (01/01/2026 through 12/31/2026) at the pricing stated in Exhibit A – Revised-1, Pricing Schedule, Section 6.E, Items 1 - 2.
3. The new expiration date is December 31, 2026.

For and in consideration of the amount stated above, which is the final contract modification amount agreed to by both parties, the receipt of and sufficiency of which is hereby acknowledged and confessed.
