

**10. DESCRIPTION OF CONTRACT MODIFICATION:**

This contract modification is made in accordance with Exhibit E-Revised-1, Contractual Terms and Conditions, Section 19. CHANGES, to be made part of hereof for all pertinent purposes. The changes are as follows:

Refer to Exhibit A-Revised-4, FPR PRICING. Exhibit A Revised-4 is hereby replaced in its entirety with Exhibit A-Revised-5, attached hereto and incorporated herein for all pertinent purposes. This modification adds two new job descriptions, *Community Engagement Support Specialist* and *Facility Management Specialist I*, incorporating the fully burdened hourly rates as reflected in item numbers 24(a-c) and 25 (a-c) starting in Section 7.B. BASE PERIOD 2 (Year 2 of the Contract) through OPTION PERIODS 1-3 of same item numbers. The changes are denotated in highlighted red font.
