1. This Contract Modification is made in accordance with Exhibit E – Revised-2, Contractual Terms and Conditions, Paragraph 4, OPTION TO EXTEND CONTRACT TERM, to be made a part hereof for all pertinent purposes.
2. This modification 1 exercises a twelve (12) month unilateral option for Option Period 1 of the contract (03/03/2025 through 03/02/2026) at the pricing stated in Exhibit A, Pricing Schedule, Section 9 Option Year 1, Subsections 9.A and 9.B, Items A., A.1, B and B.1 inclusive.
