

1. This Modification is issued to exercise a twelve (12) month unilateral extension option in accordance with Exhibit A-Revised-1, Section 10, **PRICING FOR ELECTRICAL SERVICES OUTLINED IN EXHIBIT F – SCOPE OF SERVICES OPTION PERIOD 2 – YEAR 4 OF THE CONTRACT**, at the fully burdened rates as indicated with items 1-7.
2. The Term of the Contract is hereby extended to February 13, 2027.
