**10. DESCRIPTION OF CONTRACT MODIFICATION:**

1. Exhibit E – Revised-1, Contractual Terms and Conditions, Section 4. TERM included an incorrect statement regarding the Contract term. This Modification # 1 is issued to memorialize the correction.
