10. DESCRIPTION OF CONTRACT MODIFICATION:

This Modification 3 is issued in accordance with Exhibit E, Contractual Terms and Conditions, Section 4, **OPTION TO EXTEND CONTRACT TERM** to be made a part hereof for all pertinent purposes. The changes are as follows:

1. This Modification 3 is issued to exercise a twelve (12) month unilateral extension option in accordance with Exhibit E, Contractual Terms and Conditions, Section 4, entitled **OPTION TO EXTEND CONTRACT TERM** for the fully burdened labor rates specified in Exhibit A-1-Revised-3, Pricing Schedule, Section 1. C, Option Year 1 (Contract Year 3).
2. The Term of the Contract is hereby extended to March 12, 2027.
