10. DESCRIPTION OF CONTRACT MODIFICATION:

This Modification 2 is issued in accordance with Exhibit E, Contractual Terms and Conditions, Section 4, **OPTION TO EXTEND CONTRACT TERM** to be made a part hereof for all pertinent purposes. The changes are as follows:

1. This Modification is issued to exercise a twelve (12) month unilateral extension option in accordance with Exhibit A-1-Revised-1, Section 3, **PRICING-OPTIONAL PERIOD 2**, as outlined in **EXHIBIT F – SCOPE OF SERVICES**, at the fully burdened rates as indicated with Groups A-C, Items 1-10, and Group D, Items 1-2.
2. The Term of the Contract is hereby extended to March 27, 2027.

For and in consideration of the amount stated above, which is the final contract modification amount agreed to by both parties, the receipt of and sufficiency of which is hereby acknowledged and confessed.
