**10. DESCRIPTION OF CONTRACT MODIFICATION:**

This modification is made in accordance with Exhibit E, Section 20, CHANGES, and makes the following changes to the Contract for all pertinent purposes:

1. This modification exercises Option Period 1 (Contract Year 2) in accordance with Exhibit E, Contractual Terms and Conditions, Section 4. Option to Extend Contract Term, at the unit pricing for items listed in Exhibit A-Revised-1, Pricing Schedule, Section 8. PRICING: OPTION PERIOD 1 (CONTRACT YEAR 2), in the estimated total amount of \$86,167.00. The not-to-exceed contract amount is increased to \$194,460.00 and the contract term is extended for 12-months from October 9, 2025, through October 8, 2026.
2. **The new Contract expiration date is October 8, 2026.**
